Licence for the wholesale vend of denatured spirit

licence for the wholesale vend of denatured spirit is hereby granted to _____ at _____

_____ subject to the following conditions, the infraction of which, or a conviction for any offence under
the Excise, Opium or Dangerous Drugs Laws shall render the licensee liable to confiscation of his licence in addition to
any penalties imposed under the above laws:

CONDITIONS

1. The supply of denatured spirit in any month/year shall not Exceed _____ bulk gallons. The licensee shall not obtain denatured spirit fraudulently in excess of the monthly or annual quota fixed for his shop.
2. Sale shall only be made in quantities exceeding the limit of retail sale fixed for the district, and:
 - (a) to persons possessing a permit in Form F.L. 18 the Collector of the district,
 - (b) to licensed retail vendors of the district in quantities not exceeding that specified in the vendors licence in Form F.L. 17.
3. All sales made under this licence shall be covered by a pass in Form F.L. 27 granted by the wholesale vendor.
4. The licensee shall maintain in Form F.L. 30 an accurate and up-to-date account of all sales of denatured spirit made from his premises to retail vendors of the district holding licence in Form F.L. 17 or to permit in Form F.L. 18. This register F.L. 30 shall have separate pages allotted for individual purchasers arranged in alphabetical order.
5. A copy of the entry made in register F.L. 30 shall also be made by the wholesale vendor immediately after making issues to the purchaser on the back of the licence F.L. 17 a permit F.L. 18.
6. Supplies of denatured spirit from a distillery can be obtained only on payment of the prescribed vend fee and in accordance with the rules on the subject.
7. Spirit shall not be sold at a strength lower than 60% over proof.
8. This licence covers the right to bottle denatured spirit.
9. All containers including bottles, jars, drums or cask, etc. containing denatured spirit shall bear a label printed in red and containing skull and cross bones with a warning 'Not to be taken internally' in Hindi and Urdu. The design and style of the label and the Hindi and Urdu rendering of the word of warning shall be –

This Condition may be struck off in districts where no quota of spirit is fixed.

10. The licensee shall store all his stock of denatured spirit pertaining to a shop in the premises for which he holds this licence.

11. The licensee shall not allow any person to conduct sales in his licensed premises unless the name of such person shall have been previously submitted to the Collector for approval and endorsed by him on the licence.

12. The licensee shall maintain a correct daily accounts showing receipts sales and balance for each day.

13. The licensee shall produce for inspection his licence and accounts on demand by officers who are duty authorized to do so.

14. No attempt shall be made to render the spirits fit for human consumption.
