Licence for the retail sale of denatured spirit is hereby granted to _____ at _____ in the district of _____ from _____ to _____ subject to the following conditions. the infraction of any of which, or a conviction or any offence under the Excise, Opium or Dangerous Drugs Laws, shall render the licensee liable to the confiscation of his licence in addition to any penalties imposed under the above laws;

CONDITIONS

- *1. The supply of denatured spirit in any month/ year shall not exceed _____ bulk gallons. The licensee shall not obtain denatured spirit fraudulently in excess of the monthly or annual quota fixed for his shop.
2. The quantity of denatured spirit in the licensee's possession shall not at any time exceed _____ bulk gallons.
3. Sale shall be made only at the licensed premises.
4. Sale shall be made from sunset.
5. The licensee shall obtain denatured spirit from a wholesale vendor of his own district. He is not allowed to obtain supplies from wholesale vendor of other districts.
6. Supplies of denatured spirit can also be obtained direct from a distillery in Uttar Pradesh on payment of the prescribed vend fee and in accordance with the rules on the subject.
7. Spirit shall not be sold at a strength lower than 60% over proof.
8. This licence covers the right to bottle denatured spirit.
9. All containers including bottles, jars, drums or casks, etc. containing denatured spirit shall bear a label printed in red and containing skull and cross bones, with a warning "Not to be taken internally" in Hindi and Urdu. The design and style of the label and the Hindi and Urdu renderings of the words of warning shall be---

* This conditions may be struck off in districts where no quota of spirit is fixed.
* This condition applies only in districts where no quota has been fixed. The quota will be fixed by the Collector on a consideration of reasonable requirements.

10. Sale shall not be made at any one time ---
(1) to any person requiring the spirit for a private non-industrial purpose in excess of the limit of retail sale unless such person produces a permit granted by the Collector;
(2) to any person requiring the spirit for an industrial purpose in contravention of the terms of a permit granted by the Collector to such person, provided there is no wholesale vendor in the station.
11. All issues from the shop in excess of the limit of retail sale shall be covered by a pass in Form F.L. 27 which shall be filled in, in duplicate, one copy being handed to the purchaser and the other being kept for records.
12. The licensee shall not allow any person to conduct sales in his licensed premises unless the name of such person shall have been previously submitted to the Collector for approval and endorsed by him on the licence.
13. The licensee shall store all his stock of denatured spirit in the premises for which he holds this licence.
14. The licensee shall produce for inspection his licence on demand by officers who are duty authorized to do so.
15. The licence-holder shall maintain a correct daily account showing receipt, sales and balance for each day, and shall produce the same for inspection on the requisition of any officer authorized by Government to demand their production.
16. The licensee shall not wilfully refuse to sell denatured spirit on demand by a purchaser for bona fide purposes.
17. Sale to holders of permit in Form F.L. 18 can be made only when he is no wholesale vendor in the district. All such sales shall be endorsed of the permit.

18. No attempt shall be made to render the spirit fit for human consumption.

19. The licensee shall place at a prominent place in his shop a signboard 3" x 2" and bearing the following inscriptions in Hindi and Urdu.
