Bond for the storage and use of spirit denatured under special process for the manufacture of transparent soap.

Know all men by these present that we _____ of _____ are held and firmly bound jointly and severally in to the Governor of Uttar Pradesh (hereinafter called however which expression includes his sucessor in office or assigns) in the sum of the rupees _____ (Rs. _____) to be paid to the Governor for which payment well and to truely to be made we bind ourselves, our heirs, administrators and representatives jointly and each of us binds himself, his heirs, executors, administrators and representatives severally firmly by these presents. Dated this, _____ day of _____ 19_____. Whereas the above bounden _____ (hereinafter called the manufactures) have been permitted as from the date of execution of this bond to store and use at _____ in the district of not less than sixty degrees over proof to which five per cent of approved wood naphtha or 1 per cent of castor oil and 0.5 percent of caustic soda has been previously added (which mixture is here in after called the spirit) upon and subject to the following conditions:

- (1) The total quantity of the spirit stored on the premises of the manufacturer at the place aforesaid shall not exceed at any one time _____ bulk gallons.
- (2) The quantity of the spirit used in any one year by the manufacturers shall not exceed _____ - _____ bulk gallons.
- (3) The spirit be used solely for manufacturing transparent soap (and shall not be sold in any quantity whatsoever).
- (4) None of the spirit shall be removed from the premises of the manufacturers without the sanction of the Collector.
- (5) The manufacturers shall comply with the direction of the Collector as to the manager in which the spirit shall be stored, and, if necessary recovered by distillation.
- (6) No attempt shall be made to purify the spirit.
- (7) Duly authorized Excise Officers shall be allowed to enter and inspect the manufacturers' premises.
- (8) The manufacturers will perform and above all the conditions specified in licence No _____ dated _____ and granted to them for the purposes aforesaid and shall forfeit such licence on the breach of any of the condition therein or hereinbefore contained.
- (9) The condition in the said licence and the condition hereinbefore contained shall be binding on the heirs a legal representatives of each and all of the manufacturers as long as the said licence is not revoked.

NOTE- the condition of this bond or obligation is such that if the manufacturers shall perform, observe and fulfil all the conditions hereinbefore contained then the above written bond or obligation shall be void, but otherwise it shall remain in full force and effect.
