Form of special bond to be executed for the removal of Indian-made foreign liquor from Indian – made foreign liquor

Bottling bonded warehouses for transport/export without prepayment of duty.

This indemnity bond made the ..... Day of ..... 19 ..... between ..... ( hereinafter called ' the \* Second Surety ' ) (hereinafter collectively referred to as 'the \* Sureties ' which expression shall include his/their heirs, representatives, successors and assigns) on the second part of Governor of Uttar Pradesh (hereinafter called 'the Governer' which expression shall include his successors and assigns) on the third part

Whereas, the Licensee/Licensees having been permitted to remove.....bulk liters of India –made Foreign liquor of the strength of .....degree supported by proved from his/their bonded warehouse at.....to bonded warehouse at .....without previous payment of the duty thereon the Licensee/Licensees and the Sureties\* , execute this Indemnity bond on the terms and conditions hereinafter appearing;

And, whereas, the duty on the said quantity on Indian-made foreign liquor at present rate of Rs.....per LP liter amounts to Rs.....

Now, this bond witness and the Licensee/Licensees and the Sureties\* , jointly and severally, hereby convenants/covenant with the Governer as follows:

1. That the Licensee/Licensees shall on or before the expressions of .....days there of or within such further time as many be granted by way of extension by the collector of.....District deliver or cause to be delivered the **abovementioned** ..... L.P. litres of Indian-made foreign liquor into the custody of the officer in-charge of the said bonded warehouse
2. That if the **abovementioned** .....litres of Indian-made foreign liquor after deducting such allowance for dryage wastage's may be sanctioned shall not have been delivered at the destination as herinbefore agreed, the Licensee/Licensees and the Sureties\* , jointly and severally, shall indemnify the Governer for any loss of duty which the Governer suffer by reason of such non-delivery or short delivery by paying him on demand the duty at rate of Rs.....per L.P. litres Indian-made foreign liquor not so delivered after making the allowance aforesaid.
3. Without prejudice to any other remedy provided by law the Government of Uttar Pradesh shall be entitled to recover all dues hereunder from the Licensee/Licensees and or the Sureties\* as arrears of land revenue.
