License for retail sale of Ganja to permit holder only is hereby granted to _____
 at _____ in the district of _____
 _____ from April 1, 19 _____ to March 31, 19 _____, subject to the

following special and general condition the infraction of which or a conviction for any offence under the Excise, Opium or Dangerous Drugs Law shall render the licensee liable to the forfeiture of this license and advance deposit in addition to any penalties imposed under the above laws.

The license shall be liable to forfeiture in case the information given in the original application for license in Form G-28 is found to be wrong in any material respects.

SPECIAL CONDITIONS

1. The licensee shall ascertain from one or other of the lists of assessment of monthly license fees exhibited at the Tahsil warehouse the amount of the license fee payable by him for the preceding month in accordance with the scale in force and shall pay the same at the sub-treasury of the Tahsil within which his shop is situated, on or before the 20th of each month.
2. It shall be competent to the Collector in case of default under the last preceding condition to recover the sum due under the said condition from the licensee as if it were an arrear of land revenue.
3. The licensee shall obtain his supplies of Ganja only from a bonded warehouse established in his district.
4. The licensee shall provide himself with accurate scales and weights one-sixteenth part of a Tola, one-fourth part of a Tola, half of a Tola, and one Tola one Chhattak, two Chhattaks and four Chhattaks and shall keep the same in good condition.
5. At the entrance to the shop a signboard shall be affixed on which shall be painted the name of the vendor, the designation "Licensed vendor of Ganja" and the price at which the licensee is authorized by Government to make sales to the permit-holders. From the commencement of the year for which this licence is issued the list shall be as under :

6. The licensee is strictly prohibited from possessing or selling packets which are unsealed or which contain quantities of Ganja other than those prescribed for sale in his license. He is also prohibited from charging for the packets any prices other than those prescribed in the license.
7. The licensee must personally supervise the weighment of portion of Ganja corresponding with the weights prescribed in Condition 5 supra and have a sufficient number of such portions wrapped in paper and scale in his presence and kept ready for sale to the permit-holders at the prices authorized, provided that number of such portions sold to any permit-holder shall not exceed, in total weight, the quantity of quota fixed for that permit-holder.
8. Full right is vested in Government to enhance the duty, the scale of license fee or the fixed retail price, and to make alterations in the quantities in which sales may be made to the permit-holders at any time during the currency of this license without compensation to the licensee.
9. The adulteration of Ganja or the admixture therewith of any noxious substance or of any substance that would increase its potency or weight is strictly prohibited.
10. Any portion of the stock of Ganja which may be declared by officer. authorized in this behalf to be unfit for consumption shall be surrendered for destruction.
11. The licensee shall be bound to attend the shop daily for such time as will ensure adequate supervision of the preparation of packets of Ganja and control of sales. He shall maintain a register showing along with his signature, the date and house of his attendance and keep the same in his shop for inspection of inspecting officers.

In the event of the licensee being unable to attend the shop on any day owing to illness or emergent business the reason for his absence should be stated in the register at his next visit.

NOTE:- During the unavoidable absence of the licensee, the salesman may prepare packets but the responsibility of the licensee as to the correctness of the contents of the packets shall remain unaffected.

12(a) The license- holder directly maintain a daily account in the annexed form showing the receipts and sales of the receipts and sales of ganja each day and the balance in stock (in chhattaks and tolas):

Such accounts shall be written up as soon as the transactions for each day have been closed.

Such accounts shall be written up as soon as sales have been made to permit-holders.

13. The licensee shall, on expiry of his licence, report to the Collector the amount of stock, if any remaining in his possession. Any stock remaining in the licensee's possession at the expiration of the period fixed by the Collector for the disposal of such stock shall be surrendered to the Collector or the District Excise Officer or such other officer as the Collector or the District Excise Officer, may appoint in this behalf.

14. In the event of non-renewal of this licence, the licensee shall have no claim to compensation.
