License to collect, as Bhang, hemp plants growing spontaneously and removal of the same to contract warehouses or sale to other supply contractors of Uttar Pradesh.

is hereby licensed to collect as Bhang hemp plants which may grow spontaneously upon any ground regarding which he has made arrangements with the owner or occupier thereof within the limits named hereunder, subject to the conditions noted below:

CONDITIONS

1. This license shall be produced for inspection on the demand of any Excise Officer or other officer authorized in this behalf by the Collector.
2. All Bhang collected shall be either removed to a bonded warehouse in the licensee's contract area or sold only to persons who hold contracts for supply of hemp drugs in the State provided that all such removals and sales shall be covered by a pass granted an Excise Inspector other officer authorized by the collector to grant such passes.
3. Bhang so collected shall be stored in bags of uniform size and capacity of 25 seers or 1 maund each in a secure place and in a licality fixed and approved by the Collector until lawfully disposed of.
4. The place of storage shall at all times be open to inspection by officer of the Excise Department or other officer authorized by the Collector in this behalf and shall be under Government lock the key of which shall remain in the custody of the Excise Inspector of the circle.
5. The license-holder shall be responsible for the safe custody of his stock of Bhang and may put his own lock or take such other precautions as may be necessary for the safety of the stock.
6. All Bhang shall be thoroughly cleaned and separated from seeds, weeds, dust and dirt before storage and shall be so stored as to before from damp.
7. The license-holder shall not adulterate or mix any other substance with the Bhang in his store.
8. The license-hold shall surrender for destruction any portion of his stock of Bhang which may be declared by competent authority to be unfit for consumption.
9. Any bhang in the possession of the license-holder after the expiry of his license shall be disposed of within three months to the holder of a licence in this from or else shall be surrendered to such officer as the Collector or District Excise Officer may appoint in this behalf.
10. The business covered by this license shall not be sublet or transferred. The licensee shall not allow any person to conduct sales unless such person has been previously approved by the Collector and his name is endorsed on the license
11. An account of all receipts and issues shall be maintained in the following from and an abstract of this account shall be submitted in Form I.D. 17 to the Collector on the first day of each month.
