Licence for the retail sale Ganja and Bhang by approved head salesman / salesman to permit-holders within prohibition areas of Uttar Pradesh

Licence for the retail sale of Ganja and Bhang to permit-holder is hereby granted to _____ at _____ in the district of _____ from April 1, 19 _____, to March 31, 19 _____, subject to the following special and general conditions the infraction of any of which or a conviction for any offence under the Excise, Opium or Dangerous Drugs Laws, shall render the Licensed head salesman*/ salesman liable to the cancellation of his licence and forfeiture of his security deposits in addition to any penalties imposed under the above laws.

SPECIAL CONDITIONS

1. The said ----- shall deposit with Government the sum of Rupees - ----- in cash or in Government Promissory Notes of equivalent values as securities deposit for due fulfilment of the condition of this and observance of rules framed or orders passed by the Excise Commissioner for the proper management of hemp drugs shops under State management.

2. The security deposit made under the last preceding section shall in the event of default or breach of any condition of this licence or of any rule framed or orders passed by the Excise Commissioner or the proper management of hemp drugs shop system of direct under the system of direct the management, not be reclaimable by the licensed salesman.

NOTE--- If Government Promissory Notes or other security have been deposited the following shall be substituted for the preceding clause.

In the event of default or breach of any condition of this licence or the non-observance of any rule or ordered referred to above the licensed salesman, Government promissory notes or other security deposited shall vest in Government and shall not be reclaimable by the licensed salesman.

3. The licensed salesman shall obtain his supplies of Ganja and Bhang only from a bonded warehouse in accordance with the rules and procedure lay down by Excise Commissioner.

4. The Licensed salesman shall be provided with accurate scale sand weights, which may be prescribed by the Excise Commissioner and shall use such weights only and no other and keep the same in good condition.

5. The salesman shall be supplied with a signboard ; which shall be affixed at the entrance to the shop and on which shall be painted the words “Licensed Retail Shop of Ganja and Bhang for permit-holder only” and a list of the quantities and prices at which the salesman is authorised by Government to make sales of Ganja and Bhang to the permit-holders. From the Commencement of the year for which this licence is granted , the list shall be as under :

The licensed salesman is strictly prohibited for making sales at prices over or under those stated, in the above list.

6. No Ganja or Bhang shall be sold except in sealed packets corresponding to the weights, prescribed in the last preceding condition. The licensed salesman must personally supervise the weighments of hemp drugs and have a sufficient number of packets of each kind of drugs prepared and sealed in his presence and keep them ready for sale to permit – holders at the prices authorized.
7. The licensed salesman shall make sales only to persons holding (1) *Permit in Form F.L. 38* in respect of ganja and (2) *Permit in Form I.D. 26 for smoking of ganja by (1) bhang for industrial, scientific or medicinal purposes* (2) addicts granted by the collector of the district. He shall endorse the quantity of Ganja or Bhang sold by him on the reverse of the permit.
8. The licensed salesman is strictly prohibited from possessing or selling packets which are unsealed or which contain quantities of drugs other than those prescribed for sale in his licence.
9. The adulteration of Ganja or Bhang or the admixture therewith of any noxious substance or of any substance that would increase the potency or weight of the drugs is strictly prohibited.
10. The licensed salesman shall not permit the consumption of Ganja or Bhang in any form in his shop or other premises in his occupation.
11. Any portion of the stock of drugs which may be declared by an officer, duly authorised in this behalf, to be unfit for consumption shall be surrender for destruction.
12. The Licensed salesman shall be bound to attend the shop daily throughout the sale hours in order to conduct the sales himself as well as to ensure the adequate supervision and control of sales by the assistant salesman, if any, posted to the shop. He shall maintain a register showing, along with his signature, the date and hours of his attendance and keep the same in his shop for inspection of inspecting officers.

In the event of the licensed salesman being unable to attend the shop on any day owing to illness or any unavoidable

cause, the reason for his absence should be stated in the register at his next visit.

13. The licensed salesman shall maintain accurate daily accounts in the prescribed registers supplied by the Collector of the district and the accounts shall be written up as soon as the transactions for each day have been closed.

14. The licence may be surrendered by the licensed salesman on his giving one month's notice to the Collector.
